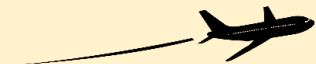


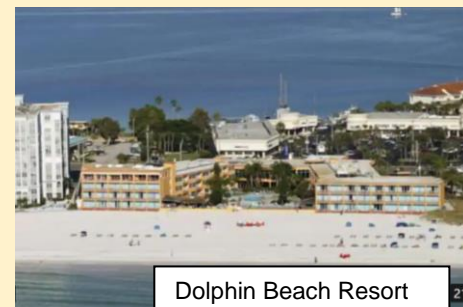

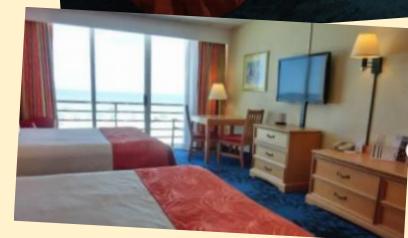

Those who appreciate the arts will enjoy the Dunedin Fine Art Center & Children's Museum where they offer year-round exhibitions in four galleries featuring national, regional and local artists. Of course a fabulous lunch is included as a group in this charming artsy town. Of course, we cannot miss with free time at the **Dunedin Downtown Market** on Fridays and Saturdays. We will have time to check out Dunedin's **Celtic Shop** to find your own clan's kilt. This Day Outing is in the works and will be announced shortly.

**Tour of Clearwater:** A visit to Clearwater must include the **Clearwater Marine Aquarium**, founded in 1972 and is a non-profit marine animal care and environmental education facility. It maintains marine exhibits for creatures such as dolphins, otters, sea turtles, sharks, stingrays, and starfish. The organization's activities also include animal assisted therapy and rescue and rehabilitation of injured marine animals. Injured dolphins and sea turtles are also rehabilitated at the Clearwater Marine Aquarium. If we are lucky, we even may see a rehabilitated creature returned to the ocean. A lovely group lunch is included and this day outing is in the works and will be finalized shortly.

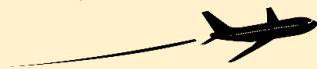
