OCTOBER 9, WEDNESDAY (DINNER)

Fly with us to **Salt Lake City, Utah**, where we will begin our seven-day National Parks adventure! On arrival we will check into the **Sheraton Salt Lake City Hotel**, where you can take some time to unwind. Tonight we will enjoy a delicious group **welcome dinner** at a local restaurant.

OCTOBER 10, THURSDAY (BREAKFAST, DINNER)

After breakfast, we check out of our hotel and take a **panoramic tour** of Salt Lake City. See the beautiful State Capitol Building, Temple Square, and many other highlights as we learn about the city's unique and fascinating history. Then we head southeast to **Moab, Utah** where we will check in for two nights at the **Homewood Suites**. Our hotel is located in the heart of charming downtown Moab. Relax or get out and explore the area before we depart for a delicious dinner at **ZAX Restaurant**.

OCTOBER 11, FRIDAY (BREAKFAST, BOX LUNCH)

Enjoy breakfast before our fun day of sightseeing begins. We will visit **Dead Horse Point State Park**, which offers views of pinnacles, buttes, gorges, and cliffs formed by the Colorado River. Upon our arrival into **Canyonlands National Park**, we will have the opportunity to walk on the **Mesa Arch Trail**, the shortest and easiest trail in the park. At **Grand View Point**, you will have a great view of magnificent rocks, spires, and mesas that rise up to 7,100 feet. On our way to **Upheaval Dome**, we'll turn off at the **Green River Overlook** for the best view in the park! Then enjoy your box lunch at the put-in spot for our **raft trip** on the **Colorado River**. Our adventure will take us from the epic vistas of red sandstone monuments and mesas into magnificent canyons with 320 million years of geologic history. Late this afternoon we will return to our hotel for a relaxing evening and time to explore downtown Moab.

OCTOBER 12, SATURDAY (BREAKFAST, DINNER)

Following breakfast this morning, we will check out of the hotel and head for **Arches National Park**. We will be amazed at the extraordinary product of erosion in the form of giant arches, windows, and pedestals that change color with the sunlight. In downtown Moab you'll have free time to have lunch before we head north to Green River. Here, we will explore the **John Wesley Powell River History Museum**. Learn the significance of river history through the cultures and landscapes of the Colorado Plateau. Sit back and admire the views on our picturesque drive to **Capitol Reef National Park**. We'll take a brief stop in the Visitors Center before venturing into the park. Marvel at a world of spectacular colored cliffs, hidden arches, massive domes, twisting canyons, limitless sky and desert rock. We'll get a real feel for what our planet might have looked like millions of years before life appeared, when nothing existed but earth and sky. This evening we will check into the **Capitol Reef Resort** in **Torrey, Utah**. Enjoy dinner at **The Pioneer Kitchen** tonight.

OCTOBER 13, SUNDAY (BREAKFAST, DINNER)

Enjoy breakfast this morning before we check out and begin another day full of unique and magnificent adventures! Our scenic drive takes us south along Utah's **Highway 12 Scenic Byway**, which winds through alpine mountains and colorful rock formations. We'll see the **Grand Staircase-Escalante National Monument** before our arrival into Bryce Canyon. After time for lunch, we'll spend the afternoon with a professional guide in **Bryce Canyon National Park**. You will be absolutely awestruck by the indescribable beauty found in this 36,000-acre park. The long series of amphitheaters filled with eroded



limestone towers called hoodoos make this one of the most photogenic places in America. We'll make several stops in the park and you will have time to hike or simply relax while soaking up this enchanting fairyland of stone. Later this evening, our scenic journey brings us to the **Hampton Inn Springdale** for one night. Springdale is the gateway community to Zion National Park and provides spectacular scenic views in every direction. Tonight's **dinner** is included at a local restaurant.

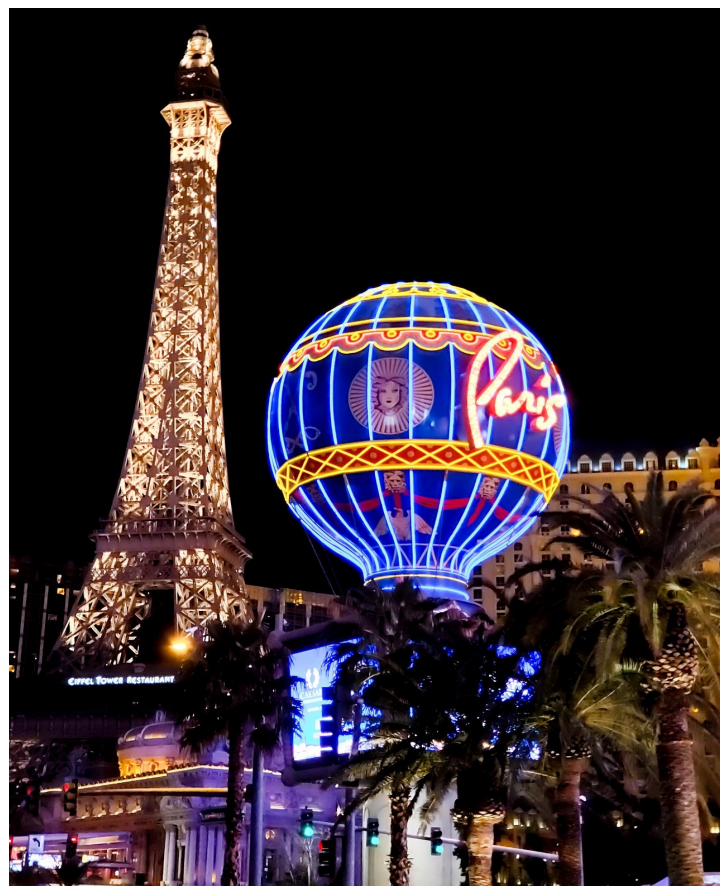
OCTOBER 14, MONDAY (BREAKFAST, LUNCH)

After breakfast, we will enter **Zion National Park**. We'll explore the Visitor's Center before taking a **narrated tram tour** through Zion, which will take us past sheer rust-colored sandstone cliffs that rise thousands of feet in every direction. Hanging gardens cling to the porous rock while a forest of Cottonwood trees accompany the Virgin River on its carving path through the depths of the canyon. Every turn in the road is a photo stop. We'll have lunch in the lodge before we begin our drive to dazzling **Las Vegas**, where we will check into the **Paris Las Vegas Hotel** for one night. This upscale hotel features Parisian flair and an abundance of amenities. The evening is free for you to explore the hotel and the bustling Las Vegas strip!

OCTOBER 15, TUESDAY

We'll depart this morning for one of the Seven Industrial Wonders of the World - the **Hoover Dam!** Located not far from Las Vegas, on the border of Arizona and Nevada, this concrete arch-gravity dam in the Black Canyon of the Colorado River was constructed during the Great Depression. We'll walk through the original construction tunnels and will feel the vibration created by water rushing through the pipes. The views are phenomenal from the Penstock viewing platform, while the exhibit gallery in the visitor center offers the fascinating story of the building of the dam.

Later this afternoon, we'll make our way to the Las Vegas airport for our flight home. We'll be taking fond memories of the beautiful sites and fun activities we experienced in the *Canyonlands of Southern Utah!*

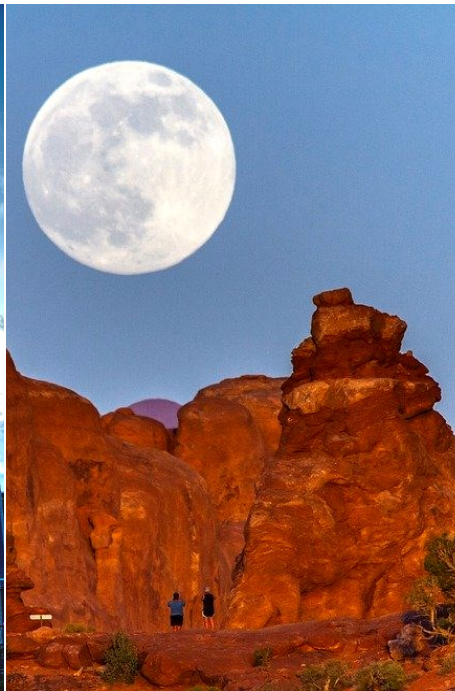
