

Walking Tour of French Lick West Baden Museum with Genealogy 101

Learn about the famous artists, politicians, and sports figures who once called the area home. Patty Drabing is not only Director of French Lick West Baden Museum, avid historian and genealogist, she's also an adoptee who searched and found her birth family during the early years of the internet. For the past 20 years, she's been a volunteer Search Angel & for the past 5 years, president of DNAAdoption.org which offers classes & emotional support for those navigating DNA results during their adoption searches and misattributed parentage cases using genetic genealogy.

Bear Hollow Wood Carvers and a scoop of French Lick's Ice Cream!

"Cutting Edge Art", along with one-of-a-kind chainsaw sculptures created by award-winning carvers from across the US, including Jason Emmons. Find truly unique gifts, such as soaps, syrups, home décor, and more by the best artisans in the country. During your free time, make certain to roam the town by maybe hopping on the trolley or see what our hotel French Lick / West Baden has to offer and browse through all the wonderful gift shops! May 18 – Wednesday (Breakfast / Lunch)

Enjoy the state's second largest, and cleanest, man-made lake with more than 27,000 acres of lush forests and wildlife viewing such as bald eagles and Osprey. Relax on board a 60' tour boat with indoor as well as open-air upper deck viewing areas. **Patoka Lake Tour and Lunch** will be aboard the boat and a Cash bar is available.

Historic Landmarks Walking Tour of West Baden Springs Hotel This former "Eighth Wonder of the World" was a lavish resort when opened in 1902. This 60-minute guided walking tour features the elegant Atrium, restored lobby, lush gardens and mineral springs pavilions. Gain a deeper appreciation for the massive multi-million-dollar renovation project at this exquisite hotel that has been designated as a National Historic Landmark and recipient of numerous accolades and awards.

Tour of Hinshaw Rock N' Gems and Tour of Pete Dye Mansion

The Hinshaw family has been creating beautiful jewelry since 1961. Nationally acclaimed lapidary artists design and create unique jewelry, decorative items, and guitar picks. Enjoy a tour of the Hinshaw's family facility where they take ordinary rocks and turn them into one-of-a kind jewelry!

Tour of Pete Dye Mansion with Group Picture. The Mansion at Pete Dye provides the ideal setting overlooking the breath-taking course carved into the hills of southern Indiana by legendary course-designer Pete Dye. The clubhouse is the mansion home built by former Indianapolis Mayor Thomas

Taggart for his son Thomas D. Taggart and his family. The Taggarts owned the French Lick Springs Hotel from 1901-1946.

May 19 – Thursday (Breakfast / Dinner)

Today we head over to Nashville Indiana in Brown County and begin the day at **TC Steele Indiana State Museum Historic Site**. The United States Dept. of the Interior added the TC Steele House and Studio to the National Register of Historic Places on Oct. 2, 1973. American impressionist painter Theodore Clement Steele (1847-1926) and his wife Selma moved to Brown County, Indiana in 1907 and established a home, studio and gardens on 211 acres of scenic terrain. The picturesque landscape of this area, and Steele's prominence, drew in other artists, establishing an Art Colony of the Midwest.

Next, we head over to the **Brown County Visitor Center** to view a movie on the history of the settlers to this area followed by a **Trolley History Tour of Nashville IN**. Finally, free time to shop! At the end of the day, we head over to Columbus IN for our stay at the beautiful and artistic Indigo Hotel. Fabulous **Dinner on the River at Upland Columbus PUMP HOUSE**.

May 20 – Friday (Breakfast)

Did you know... Columbus, Indiana is ranked sixth in the nation for architectural innovation and design by the American Institute of Architects, right behind Chicago, New York, San Francisco, Boston and Washington, D.C. Visitors to Columbus can see more than 70 buildings and pieces of public art by internationally noted architects and artists, including I.M. Pei and Eliel Saarinen. The Columbus story has been featured in CBS's Sunday Morning, National Geographic, The New York Times, The Chicago Tribune, and Midwest Living.

After breakfast, we head over to the **Columbus Visitor Center** where our guide will showcase the **downtown Columbus city tour** honoring both historic and contemporary buildings as well as public art, interwoven with stories of the people instrumental in shaping our community. At the conclusion of our tour, we are homeward bound with wonderful memories of French Lick, Brown County and Columbus Indiana.
