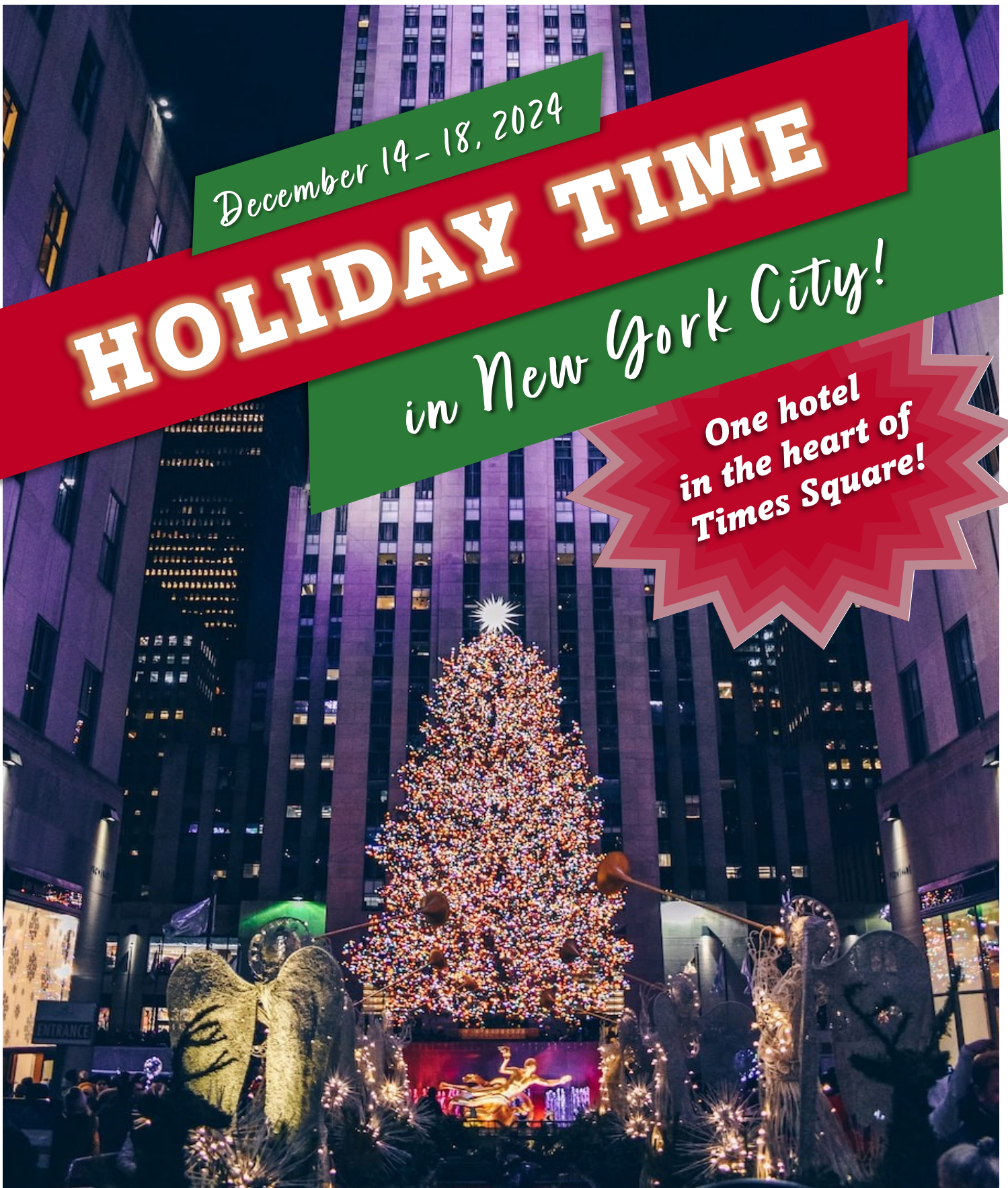

SUNDAY, DECEMBER 15 *(Brunch, Dinner)*

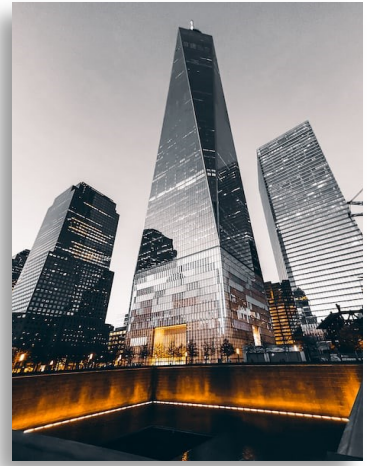

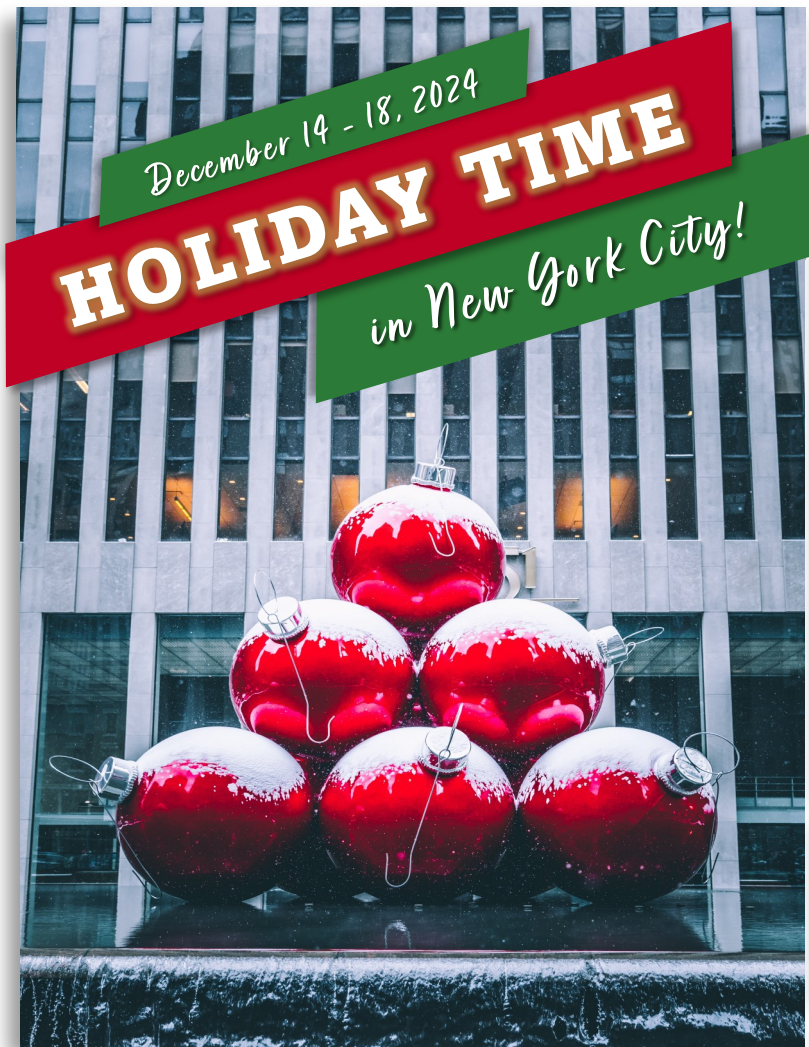

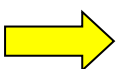
