Monday, January 13

San Juan, Puerto Rico

Puerto Rico's 500-year-old capital is a history buff's dream come true. Hop aboard the free, open-air trolley in Old San Juan to see the city's top sites. Explore Castillo De San Felipe Del Morro, the fort that has helped guard the shore for nearly five centuries while overlooking some of the island's best scenery. Venture further out from the old town and nature unfolds. You can scale high into the jungled mountains of El Yunque Forest, or keep to the foothills on a riverside horseback ride.

Tuesday, January 14

Charlotte Amalie, St. Thomas

Arrive 8:00 am

Marvel at the blue waters peppered with sailboats and green hills dotted with quaint little cottages. Explore colonial landmarks like Blackbeard's Castle or raise a pint of the local lager at quaint microbreweries. Head to Government Hill, Drake's Seat on Skyline Drive, and Mountain Top, which rises over 1,500 feet above sea level for unbelievable panoramic views of paradise. And of course, no visit is complete without a stop at Magen's Bay, named one of the world's most beautiful beaches by National Geographic.

Wednesday, January 15

St. Johns, Antigua

Discover the beaches hidden among the cliffs and bays. The lush rainforest, dramatic landscapes, and turquoise waters will tempt adventurers from swimmers to hikers. Swim and snorkel with gentle stingrays or snorkel the coral reefs that teem with life. Take a scenic catamaran sail or lie on a golden beach and sip a rum punch. Designer fashions and local crafts can be found in the duty-free shops.

Thursday, January 16

Basseterre, St. Kitts and Nevis

There are so many fascinating features to discover, how will you choose where to start? Explore French and English colonial architecture, breathtaking beaches, and lush landscapes beneath soaring mountain peaks. Visit the 350-year-old Romney Manor estate and formal gardens. Tour Brimstone Hill Fortress, a UNESCO World Heritage site, 750 feet above the Caribbean. Ride a narrow-gauge train through breathtaking scenery and take in magnificent views of Mount Liamuiga, a 3,792-foot-high dormant volcano. For lunch, seek out rustic plantation homes that serve hearty West Indian fare.

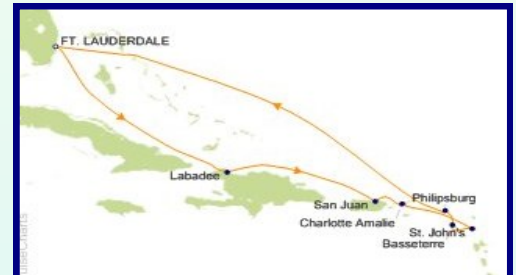
