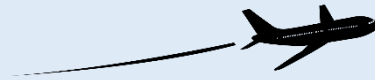

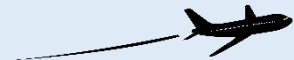

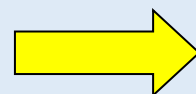

If you request a variation or change to your booking, TFP and DWN may choose to accept or reject that request. If accepted, you are responsible for any fees associated with it. If the minimum number of passengers required to operate the tour is not met, TFP and DWN reserve the right to cancel the tour.

It is the discretion of TFP and DWN to refuse transport to any passenger, or require any passenger to leave the tour, if it is reasonably believed that the passenger (1) is dangerous to others or to himself or herself; (2) is engaged in, or is threatening to engage in behavior that may adversely affect the safety, security, enjoyment, or well-being of other passengers, including behavior that is disruptive, verbally or physically abusive, obnoxious, harassing, or obscene; or (3) has failed or refused to follow TFP and DWN rules and procedures or the instructions of its representatives. In the event a passenger is removed, such passenger may be left at any location without any liability to TFP and DWN or its representatives. TFP and DWN shall not be required to refund any portion of the price paid by any passenger who is removed, nor shall TFP and DWN be responsible for any further expenses incurred by the passenger.
